

At ABC Motor Home Rentals our travel trailers come fully equipped and ready to roll, this includes high quality linens and a fully equipped kitchen.

Travel trailer rentals require a minimum 3-day rental. A \$500.00 non-refundable Credit Card deposit is required to confirm a booking.

YOU WILL NEED:

+ Renters must verify with their auto insurance provider that Liability extends to a trailer/ towing. You will need to provide your personal auto insurance card upon renting the trailer.

+ It is the Renter's responsibility to confirm that their personal vehicle is capable and safe to tow one of our trailers. The towing capacity and the Gross Combined Vehicle Weight Rating for the trailer, passengers, cargo, and vehicle must not be exceeded. Specifications of our trailers are listed on their respective web pages, and in the booking engine. If renter shows up with an unsafe tow vehicle, renter will not be allowed to use trailer and all deposits will be forfeited. Our you may Rent a vehicle from ABC Motorhome that is deemed suitable for towing the unit Assigned.

+ Renter must have a 7-pin RV style wiring harness receiver. 4-pin, or "4-flat" are not adequate. 7-way trailer plugs have a 12v powered input (so the batteries of trailer charge while driving, and the fridge can be run on DC power) and an input for electric brakes- also VERY important.



This is what the plug from trailer looks like:



This is what the 'female' end needs to look like on your vehicle:

- + A 2" ball is required for all our trailers. We can provide upon advance request. All vehicles must have a 2" receiver, none of our trailers are light enough for smaller 1" or 1.5" receivers!
- + The hitch receiver on your tow vehicle must be at least 16" off of the ground.

WHAT IS INCLUDED:

The daily rental price includes everything for up to 3 people. The kitchen comes fully stocked for 3 people in our R-pod units), this includes pots and pans, spices, kitchen tools, silverware, plates, cups, coffee press, etc. Bedding is also provided, either traditional sheets and blankets or sleeping bags with pillows.

- Return it clean with the black and gray tanks empty and there are no additional charges.
- If you do not bring back trailers as received, these are the fees to be assessed: \$20 for propane (they are exchange cylinders, we have service at the shop so you can either replace with a full cylinder with receipt, or you will be charged \$20), \$150 for sewage and gray water empty, \$200.00+ for cleaning depending on how bad it is. You do not need to refill the clean water.
- These are non-smoking units. \$500+ cleaning fee if we even get a faint whiff of tobacco or pot.
- Renter must have full-coverage US auto-insurance that allows towing. No exceptions. This goes whether you drive your car or one of ours. As of now, this product is not allowed for those that do not have an appropriate US auto insurance

- policy. Sorry foreign friends. Check out our Motor Home Rentals or European style camping Van as an option

All renters of our travel trailers are required to sign our rental agreement and release of liability and indemnity agreement. If you are not willing to sign the agreement, then you should seek a rental elsewhere. Here is the exact wording: [Trailer Liability Waiver 2017](#)

I, as a voluntary participant in a recreational activity attendant to the use of a trailer, recognize that ABC Motor Home Rentals and its members, managers, officers, employees, agents, and affiliates (ABC Motor Home Rentals) make every effort to provide a safe and enjoyable experience with its rental equipment. However, the risk of injury and/or death arising out of the use of some of the rental equipment simply cannot be eliminated without jeopardizing the essential qualities of the activities attendant to the rental.

Hazards and Risks: I understand that hazards and conditions of nature may pose a risk to my safety while participating in activities associated with the equipment rented to me

by ABC Motor Home Rentals. I expressly acknowledge my own responsibilities in the use of, as well as the inherent risks associated with, the following rentals:

TRAILER RENTAL

I, the renter, represent that I have made myself aware of the proper use of trailers including but not limited to how the trailer is hitched to the vehicle and how to operate a vehicle with a trailer attached. I understand that towing trailers affects the vehicle's performance while I am operating it. It may take longer for the vehicle to stop, to accelerate, and be more difficult to maneuver. In high winds, the trailer may sway, and cause the vehicle to sway as well, which can cause accidents resulting in injury and/or death.

The use of trailers also increases a vehicle's gas consumption and I acknowledge that I will need to account for this when I am traveling in remote areas to avoid being stranded.

I understand that if a trailer is not properly secured when parked, the trailer may roll into or over persons causing injury and/or death. It may also damage equipment and personal property. Additionally, if an unsecured trailer rolls, or if I attempt to move or tow the trailer while a person is on the trailer, the person may be injured and/or die if the person falls off of the trailer or in the event of an accident involving the trailer. I expressly agree that no person shall be on the trailer while it is in motion.

I understand that, in the event equipment and/or cargo on the trailer is not properly secured, such equipment may fall off the trailer when I attempt to move the trailer. Falling equipment and/or cargo may damage the equipment and/or cargo and cause injury and/or death.

RELEASE OF LIABILITY, WAIVER OF CLAIMS, EXPRESS ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration for being permitted to rent equipment from ABC Motor Home Rentals, its agents, affiliates, or partners, I, on behalf of myself, my child, or our personal representatives, heirs, next-of-kin, spouse, and assigns, hereby acknowledge and agree that:

1. I am voluntarily using ABC Motor Home Rentals' services and equipment and have made a free and deliberate choice to sign this agreement. I have concluded that

the risks involved and the release and waiver of liability is worth the pleasure of engaging in the activities associated with the rental equipment. I consider myself or my child physically and mentally capable of participating in all the activities in which I choose to participate.

2. I HEREBY RELEASE AND HOLD HARMLESS WITH RESPECT TO ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER CAUSED BY NEGLIGENCE OR OTHERWISE, and any of Ex ABC Motor Home Rentals' officers, directors, employees, representatives, agents, independent contractors, and volunteers (hereinafter the "Releases").

3. I agree to INDEMNIFY, DEFEND, SAVE, and RELEASE the Releases, from any liability and responsibility whatsoever and for any claims or causes of action that I, my estate, heirs, survivors, executors, or assigns may have for death, personal injury, property damage, disability, illness, disease, or damage to me or to spectators or other third parties arising from ANY NEGLIGENCE or FAILURE TO EXERCISE REASONABLE CARE of the Releases or otherwise.

4. By entering into this Agreement, I am not relying on any oral or written representation or statements made by the Releases, other than what is set forth in this Agreement.

5. I EXPRESSLY ASSUME the risk of death, injury, or damage that may result from any of the listed or other unlisted, known or unknown, natural or man-made hazards with dangers associated with my participation in activities provided by or associated with the rental equipment.

6. I expressly agree that this Liability, Waiver of Claims, Express Assumption of Risk and Indemnity Agreement is governed by the laws of the State of Montana and is intended to be as broad and inclusive as is permitted by Montana law, and that in the event any portion of this Agreement is determined to be invalid or unenforceable for any reason, the balance of the Agreement shall not be affected

or impaired in any way and shall continue in full legal force and effect. Any suit that I may bring against the Releases must be brought in Alaska state courts.

7. I agree the prevailing party shall have the right to collect from the other party its reasonable costs and necessary disbursements and attorneys' fees incurred in enforcing this Agreement.

BY SIGNING THIS DOCUMENT, I MAY BE WAIVING MY LEGAL RIGHT TO A JURY TRIAL, TO HOLD THE PROVIDER LEGALLY RESPONSIBLE FOR ANY INJURIES OR DAMAGES RESULTING FROM RISKS INHERENT IN THE SPORT OR RECREATIONAL OPPORTUNITY OR FOR ANY INJURIES OR DAMAGES I MAY SUFFER DUE TO THE PROVIDER'S ORDINARY NEGLIGENCE OR FOR INJURIES OR DAMAGES RESULTING FROM RISKS INHERENT IN THE SPORT OR RECREATIONAL OPPORTUNITY THAT ARE THE RESULT OF THE PROVIDER'S FAILURE TO EXERCISE REASONABLE CARE.
